Transport	Dangerous / not safe when dropping off pupils	16	There is no proposal to change the current procedures. Any changes to the highway is outside the scope of the project.
	Limited parking for parents and staff		There is no increase in staff or pupil numbers, and the number of car parking facilities remain. On street parking is available in the surrounding streets which are currently not restrictive with residents parking. The School should continue to monitor staff parking and encourage wherever possible a public or other modes of transport including car sharing as part of their evolving travel plan. The new nursery will attract more staff, however the Traffic Impact Survey illustrates the impact of additional on street parking on the surrounding streets will be minimal.
